Complete		 MMR (Measles, Mumps & Rubella) - Proof of two vaccines or positive antibody titer for all 3 components required. Varicella (Chicken Pox) – Proof of two vaccines, <u>OR</u> positive antibody titer required. History of disease is not accepted. Hepatitis B –UI CON is unique in requiring a titer (blood test) in addition to the vaccination series. You must have documentation of one of the following: Series of 3 vaccinations <u>and</u> a positive antibody titer OR 2 Heplisav vaccinations <u>and</u> a positive antibody titer If your Hepatitis B titer is negative, repeat the series followed by a second titer. TB (Tuberculosis) Skin Test (TST): A two-step TB skin test (TST) or the Interferon Gamma Release Assay (IGRA) (blood test) for TB antibodies. See more at <u>Two-Step TST Protocol</u>. Note: A one-step TB skin test will be due <u>annually</u>. Tetanus – 1 Td (tetanus/diphtheria) at least every 10 years. You must have documentation of 1 Tdap (tetanus, diphtheria, pertussis) vaccine.
